Festival Regulations for 2024 (please read & keep this page)

These regulations are part of your contract with the Somerset Harp Folk Harp Festival.

Acceptance of this agreement is for the year 2024 only.

First responders during our early-bird can request specific locations with the Festival director. First come, first served. After that period, the Festival Director will assign all spaces

Sharing Booths. You may arrange to share a booth with one other exhibitor, with the consent of the Festival Director. The exhibitors whose names appear on this contract are the only entities allowed to exhibit in the booth assigned.

Only those products/services listed on your contract are allowed in your booth and you may promote these only *within the confines of your booth*.

Booth/Table boundaries: Booth sizes are 10x10 feet. Please be advised that we will be rigorously enforcing booth boundaries. No part of your exhibit may exceed 10 feet. **Table vendors:** Your boundaries are the top of your table and behind your table.

Security: Exhibits must be ready and staffed at the time the exhibit hall opens and be manned at all times or monitored by a neighboring vendor. Exhibitors and their staff must wear name badges at all times in the Festival area. These will be provided by the Festival.

All exhibits must have their name boldly displayed. We reserve the right to remove signs that are of poor quality.

Nothing edible or drinkable may be sold or dispensed without prior approval.

All exhibits must be orderly and blend in with the folk harp theme of the Festival.

There is absolutely NO SMOKING in any part of the Festival.

Please feel free to contact Maureen at any time during regular business hours to discuss any issues you have or ideas for making the festival, and you, more successful.

The Exhibitor Kit will be emailed to you. Please review details that will affect your costs, particularly with regards to shipping and on-site services such as electrical hook-ups.
